

2016-2018 **PEBEC REFORMS** Reference Handbook







Ease Of Doing Business -Completed Reforms

Over the past 3 years, Nigeria has implemented more than 140 reforms, increased its Distance-to-Frontier (DTF) score by over 11 basis points, and moved up 24 places in the World Bank Doing Business Index (DBI) rankings.

In the 2018 Global Competitiveness Report, the World Economic Forum (WEF) recognized Nigeria's business environment as one of the most entrepreneurial in the world, and highlighted Nigeria's improved competitiveness in the Enabling Business Environment.

Below are some of the benefits of the reforms delivered.





For STARTING A BUSINESS, Nigerians can now:

- 1 Complete the reservation of a business name online within 4-hours
- 2 Register a company and pay registration fees online with the Corporate Affairs Commission (CAC) via the Company Registration Portal (CRP) within 24 hours
- 3 Pay online and obtain a Business Premises Permit via an automated process
- 4 Automatically generate a Tax Identification Numbers (TIN) with the Federal Inland Revenue Service (FIRS) upon completion of registration without requiring a company seal







VIRONMENT COUNCIL (PEBEC)

For ENTRY AND EXIT OF PEOPLE, Nigerians can now:

- 1 Enjoy a simplified and more efficient visa-on-arrival process
- 2 Expect approval of visa-on-arrival applications electronically within 48hrs
- 3 Enjoy the absence of mandatory baggage search by airport officials
- 4 Demand airlines' compliance with Passengers Rights
- 5 Make e-payments for services at all FAAN operated airports in line with cashless policy
- 6 Report/provide feedback on experience or issues via the PEBEC kiosks at the MMIA and NAIA, or online at pebec.report





For PAYING TAXES, Nigerians can now:

- 1 File and pay all Federal Taxes electronically
- 2 Access fully disclosed audit guidelines online
- 3 Use electronic self-service help desks at all Federal Inland Revenue Service (FIRS) offices





ENVIRONMENT COUNCIL (PEBEC)

For TRADING ACROSS BORDERS, Nigerians can now:

- 1 Expect 24/7 operations of Apapa port, with a reduced number of procedures and agencies at the port
- 2 Demand one single joint cargo inspection for imports and exports
- 3 Digitally submit fewer shipping documents for import (from 14 to 8) and export (from 10 to 7)
 4 Expect the issuance of approval of FORM-M by banks
- 4 Expect the issuance of approval of FORM-M by banks within 24 hours
- 5 Demand the issuance of a Clean Certificate of Inspection (CCI) within 48hours after receipt of all export documents
- 6 Expect the inspection of exports and issuance of SONCAP certificates within 48hours
- 7 Report non-compliance by pre-shipment agents for sanctions to be instituted





For GETTING CREDIT, Nigerians can now:


- 1 Enjoy more opportunities to access credit for small businesses through the
 - a. successful passage of the Credit Reporting Act (Regulation and licencing of Credit Bureau) Act and the Secured Transactions in Movable Assets (a) Act
 - b. creation of a National Collateral Registry (NCR)





For GETTING ELECTRICITY, Nigerians can now:

- 1 Expect new connections to the distribution grid for maximum demand (MD) customers within 30 days due to more efficient procedures
- 2 Utilise the new e-system to apply and secure approval for new connections to the grid by distribution companies including EKEDC, IKEDC, KEDCO, EEDC, etc.







For TRADING WITHIN NIGERIA, Nigerians can now:

- 1 Expect completion of NAFDAC product registration within 90 days
- 2 Enjoy improved efficiency and reduced response times overall due to the
 - a. Automation of port operations processes by NAFDAC
 - b. Clearance of backlogs of registration applications by NAFDAC
 - c. Clearance of backlogs of outstanding marks by the Trademarks Registry
 - d. Elimination of the interception by SON of compliantly cleared containers





For ENFORCING CONTRACTS. Nigerians can now:

- 1 Access published Court of Appeal judgments electronically
- 2 Enjoy limitation on adjournments in the specialised small claims commercial courts in Lagos State
- 3 Access specialised small claims commercial courts in Lagos and Kano States
- 4 Request a pre-trial conference for specialised small claims commercial courts in Lagos State







IVIRONMENT COUNCIL (PEBEC)

For DEALING WITH CONSTRUCTION PERMITS - LAGOS, Nigerians can now:

- 1 Enjoy an improved planning permit application process via an e-planning platform for Lagos State
- 2 Access accurate information on all fees, procedures, requirements and laws on the Lagos State Physical Planning and Permit Authority (LASPPPA) website
- 3 Access statistical information on land disputes
- 4 Enjoy reduced costs for permits due to the elimination of requirements for
 - a. infrastructure development charge (IDC) for 2floor warehouses
 - b. soil test and environmental impact assessment (EIA)
 - c. certified true copy (CTC) of title document and survey plan
- 5 Expect water connection within 3 days of your payment to the Lagos State Water Board





VIRONMENT COUNCIL (PEBEC)

For DEALING WITH CONSTRUCTION PERMITS - KANO, Nigerians can now:

- 1 Submit an application and make e-payments for building plans simultaneously at the Kano Urban Planning and Development Authority (KNUPDA)
- 2 Expect to receive building plans within 14 days
- 3 Expect water connection in 7 days of your payment to the Kano State Water Board
- 4 Request the issuance of a Certificate of Habitation without physical inspection
- 5 Appoint private professional firms to carry out inspections before, during and after construction





IRONMENT COUNCIL (PEBEC)

For REGISTERING PROPERTY – LAGOS, Nigerians can now:

- 1 Receive demand notices via email, and pay online for charting fee, endorsement fee, stamp duty, registration fees, consent fees and neighbourhood improvement charges
- 2 Obtain certified true copy (CTC) of title documents and survey plans at the Land Registry's automated centre





VIRONMENT COUNCIL (PEBEC)

For REGISTERING PROPERTY – KANO, Nigerians can now:

- 1 Enjoy an automated process for registration of properties, including rapid capture at the Land Registry
- 2 Enjoy expedited issuance of Governor's Consent through delegation of issuance authority to the State Attorney-General and Commissioner for Justice
- 3 Conduct property searches and view estimated costs on a cadastral map via the Land Registry
- 4 Access clear information on acquisition and transfer of property via the Kano Bureau for Land Management website
- 5 Access the linked Land Registry website and Inland Revenue Portal to make required payments online simultaneously
- 6 Enjoy harmonised title and boundary verification in the Land Registry due to full digitisation

VIRONMENT COUNCIL (PEBEC)

For SELLING TO GOVERNMENT, Nigerians can now:

- 1 Access information online from the Bureau of Public Procurement on
 - a. simplified procurement guidelines for small businesses
 - b. documentation needed and what is no longer required
 - c. processing timelines in line with the standard operating procedures of the government ministries and agencies
 - d. appropriate channels for small businesses to complain when payments are delayed
 - e. the sanctioning and prosecution process for ministries and agencies of the government who do not comply
